PART C: CONSENT FORM (Attachment)

This form must be completed by the Parent or Legal Guardian of any player who participates in any Event under the auspices of South African Schools' Hockey. It provides South African Schools' Hockey permission to process and use personal information of the data subject (player) subject to the conditions set out below and as required by Section 35 of the POPI ACT.

Any Official participating in any Event under the auspices of SASHOC must also complete and sign this form.

A. USE OF PERSONAL INFORMATION

1. The player or official, upon registration, must obtain written consent from a Competent Person (as defined by POPI Act) [in the case of an official, sign the form himself/herself] for SASHOC to collect and process Personal Information relating to the player's/official's participation in any SASHOC event. Furthermore, according to SASHOC's agreement with SUPERSPORT SCHOOLS', this consent includes but is not limited to commercial redistribution of photos and videos of players/officials participating in and attending SASHOC Events.
2. SASHOC and SSS is committed to protecting the player's/official's privacy and recognises that it needs to comply with statutory requirements in collecting, processing and distributing Personal Information. The Constitution of the Republic of South Africa provides that everyone has the right to privacy and the Protection of Personal Information Act 4 of 2013 ("POPI Act") includes the right to protection against unlawful collection, retention, dissemination and use of Personal Information. In terms of Section 18 of POPI Act, if Personal Information is collected, SASHOC, as responsible party, must take reasonably practical steps to ensure that the Data subject (player/official) is made aware of the information being collected.
3. In order to facilitate the commercial functions of SASHOC and SSS, it is necessary to utilize certain Personal Information in the form of action photographs and videos containing the Personal Information of the player/official. This Personal Information includes, but is not necessarily limited to photos and videos and other statistics and data.
4. This information is collected by SASHOC and is communicated to SSS and its affiliates, service providers and match day broadcasters. This Information may be forwarded to producers and thereafter to website developers and IT officers, usually by electronic means in the form of an email or other form of electronic communication. This Personal Information in the form of photographs and videos is necessary for purposes of contractual and commercial obligations.
5. In accordance with POPI Act, SASHOC may collect the following Personal Information for use of the Event organisers, match officials and SSS:
 - 5.1. Player's/Official's details (eg. name, address, ID number, Date of Birth, medical conditions,

Medical Aid, parent or guardian information, etc.)

5.2 For the use of broadcasting and placing on the SASHOC website:

5.2.1 Photos and videos of athletes, coaches, volunteers and match day officials participating in match day Events and games, together with action photos of supporters and/or fans in attendance.

5.3 The consent for allowing such information and data is required for the running of matches at the Event by the organisers, for the use of selectors for the purpose of selecting and identifying players for HP or International teams and for the commercial purposes of filming and broadcasting matches on the day. Furthermore the Personal Information is needed for the promotion of the Event, populating the website, other social media platforms, as well as match day programs and for other marketing purposes.

5.4 Neither SASHOC nor SSS assumes liability for the uploading and or processing of any personal information in regard to any other third-party apps or services beyond the above-mentioned scope.

6. The Data subject (and/or through the relevant Competent Person) is required to consent to the use of his/her Personal Information voluntarily and understands that same is mandatory for purposes of SASHOC events.

7. Consequences of failure to provide Consent for the use and processing of Personal Information will result in a player/official either:

7.1 not being able to compete in a SASHOC Event or;

7.2 not being able to participate in any matches organised on the particular day which may be broadcasted live or on a delayed basis.

8. Access and right to amend:

8.1 A player/official has the right to access and request amendment of his/her Personal Information at any reasonable time.

9. Complaints:

9.1 All complaints regarding the use of Personal Information may be directed to the Compliance Officer of SASHOC or the Information Regulator.

B. CONSENT

1. The parent/guardian who signs on behalf of the player, coach, manager, volunteer or any other match day official (as Data subject) by signing this document, hereby consents to the use of his/her or their minor child's Personal Information, including photographs and video footage and confirms that:

1.1 the information is supplied voluntarily, without undue influence from any party and not under any duress; and

1.2 acknowledges that he/she is aware thereof that he/she has the following rights about such Personal Information which is collected. The right to:

1.2.1 access the information at any reasonable time for purposes of rectification thereof;

1.2.2 object to the processing of the information in which case this agreement will terminate in accordance with the provisions contained herein;
